28 and the trustees will take turns asking the questions. After all the questions have been asked the

audience the meeting will be reopened and Greg will ask for public comment from the audience
about the four candidates. Greg told the Board and the audience they will be interviewing Robert

1 Moore and David Marzolf tonight.

2 Greg introduced Robert Moore to the Board and the audience and the trustees asked Robert
3 Moore a set of questions that were prepared for the candidates. After all the questions were asked
4 Greg told the Board they will take a break and will resume at 6:00 p.m. to interview David
5 Marzolf.

6 Greg called the meeting back to order and introduced David Marzolf and explained to
7 David how the interview process will work tonight. After all the questions were asked Greg told
8 the Board they will now go into a closed meeting. Greg closed the meeting.

9 Greg reopened the meeting.

10 Greg asked the audience if they have any public comments about the candidates that were
11 interviewed for the superintendent position the last two nights. After comments from the Board
12 and the audience about the candidates, Cathi Cook made a motion to hire Robert Moore as the
13 district superintendent with a 2 year contract, with a starting salary of \$95,000.00 the first year, 5
14 personal days per year and sick and vacation days earned according to state law. Dawn Shinn
15 seconded the motion. All voted aye.

16 Greg told the Board he will inform them if Robert Moore accepts the position.
